

COMMONLY ASKED WEDDING PHOTOGRAPHY QUESTIONS

Q. WHAT IS YOUR STYLE?

**A. I AM A MIX OF CONTEMPORARY AND CLASSICAL. THE CONTEMPORARY IS A PHOTOJOURNALISTIC (CANDID) STYLE WITH A BIT OF “FASHION CREATIVE” THROWN IN. THE CLASSICAL ASPECT IS ABOUT CLEAN, SIMPLE, TIMELESS IMAGES.
WITH ALL THAT SAID, I DO NOT SHOOT “TABLE SHOTS” BUT DO TRY TO PHOTOGRAPH EVERYONE AT YOUR WEDDING. IT’S IMPORTANT TO ME.**

Q. WHO WILL BE AT MY WEDDING?

A. I, CRAIG FREEMAN, PHOTOGRAPH EVERY WEDDING. I ALSO HAVE A SECOND PERSON ALONG TO DO TWO JOBS, MY ASSISTANT AND A SECOND PHOTOGRAPHER. IT’S USUALLY MY WIFE, KARI, BUT NOT ALWAYS.

Q. HOW MUCH TIME DO I NEED FOR MY WEDDING PHOTOGRAPHY?

A. IT’S A BIT TRICKY BUT I’LL TRY TO ANSWER THIS THE BEST I CAN. THE EASY ANSWER IS THIS, 8 HOURS. THAT TIME WILL COVER MOST PEOPLES WEDDING DAY INCLUDING GETTING READY, CEREMONY, AN HOUR OF FORMALS, AND MOST OF THE RECEPTION IF NOT ALL OF IT. I DO OFFER LESS TIME AND MORE TIME TO FIT ALMOST ANY WEDDING DAY.

Q. WHAT IS THE PROCESS AND WHEN WOULD WE MEET?

A. WE WOULD MEET SEVERAL TIMES. AFTER YOU HAVE FILLED OUT A CONTRACT FOR YOUR WEDDING WE WOULD SET A DATE FOR YOUR “GTKY” SESSION.

- THE NEXT TIME WOULD BE AFTER THE “GTKY” SESSION WHEN YOUR IMAGES ARE READY TO VIEW (ABOUT A WEEK OR TWO).
- THE THIRD SCHEDULED MEETING WILL BE ABOUT A WEEK BEFORE YOUR WEDDING TO GO OVER ALL THE DETAILS OF WHEN AND WHERE OF THE WEDDING AND TO TAKE CARE OF THE FINAL PAYMENT.
- YOU WOULD ALSO COME IN TO VIEW YOUR WEDDING IMAGES AND PICK UP YOUR HIGH RESOLUTION FILES ABOUT 4 WEEKS AFTER THE WEDDING.
- ANY OTHER MEETINGS AFTER THAT WOULD BE FOR PURCHASED PARENT OR BRIDAL ALBUMS.

Q. WHAT ARE YOUR PAYMENTS AND PAYMENT METHOD?

**A. THERE IS AN \$800 NON-REFUNDABLE DEPOSIT DUE AT TIME OF CONTRACT TO HOLD YOUR DATE. THE REMAINDER OF THE BALANCE IS SPLIT INTO TWO EQUAL PAYMENTS. THE FIRST OF WHICH IS DUE 120 DAYS BEFORE THE WEDDING AND THE FINAL PAYMENT IS DUE AT THE PRE WEDDING MEETING, ABOUT A WEEK BEFORE THE WEDDING.
AT THIS TIME WE ONLY ACCEPT CASH AND CHECK. SORRY NO CREDIT CARDS.**

Q. HOW LONG TILL WE SEE OUR IMAGES?

A. I AM A ONE-PERSON TEAM AND CAN BE A PERFECTIONIST ABOUT MY WORK. I TRY TO TURN WORK AROUND AS FAST AS POSSIBLE WITH OUT JEOPARDIZING QUALITY OF PRODUCT OR PHOTOGRAPHERS SANITY. YOUR “GTKY” IMAGES WILL BE READY IN ABOUT A WEEK OR TWO. YOUR WEDDING IMAGES WILL BE READY FOR VIEWING IN ABOUT 4 WEEKS.

Q. CAN WE PRINT OUR OWN IMAGES?

A. YOUR WEDDING DAY AND “GTKY” IMAGES ARE PRESENTED TO YOU IN HIGH RESOLUTION FILES ON A THUMB DRIVE. YOU ARE ALSO GIVEN A RELEASE THAT GIVES YOU (THE BRIDE AND GROOM) RIGHTS TO PRINT THE IMAGES FOR YOURSELF YOUR FAMILY AND YOUR FRIENDS. I AS THE PHOTOGRAPHER STILL HAVE THE RIGHTS TO THE IMAGES. SO TO ANSWER THAT QUESTION SIMPLY, YES!
